#### **CATALYST Testing Status**

CM is waiting for Build 12.1 of the PR Tool delivery (SCCR 962). CATALYST and the PR Tool will be tested together before either is released. The PR Tool will be delivered in the next couple of days. SCCR 962 needs to be updated to include JIRA tickets.

#### **Production Processing Status**

May need a new PR for SSF Edition1-CV due to a CC change on *magneto*.

#### **System Status**

Proposed schedule for AMI-P upgrades is September 6-11, but this is not yet approved.

Two websites have been migrated to the new Web architecture. The rest of the websites will follow with a goal to migrate all websites by September 30. There will be three areas – development, testing, and production. A question was raised regarding the process of moving updates from development to production and how long this will take?




Figure 1. PR State Diagram
